POSITION SUMMARY:

The Registered Dietitian Nutritionist (RDN) is a member of the clinical team and is responsible for the development and implementation of nutritional programs to assist in the promotion of health and the control of disease.

DUTIES AND RESPONSIBILITIES

- Work as part of the care team to evaluate patient lifestyle, nutritional, and health needs to develop safe and sustainable nutrition plans;
- Counsel patients and families on healthy practices including nutritional principles, dietary plans and diet modifications, and food selection and preparation;
- Meet regularly with patients to set goals and track progress;
- Provide medical nutrition therapy (MNT) to help manage diabetes and other medical conditions;
- Develop policies for nutrition programs to assist in health promotion and disease control;
- Develop curriculum and prepare manuals, visual aids, and other materials used in teaching;
- Participate in the development of nutrition-based programs or interventions that promote health and control disease;
- Participate in group teaching that promote health and prevent disease;
- Document patient visits in electronic medical record.
